**Bob Dylan's song said, "The times, they are a changing..."** This is so true in foster care. In the next few years we will experience more changes in how foster care is done than I have personally experienced since I founded Children First 18 years ago.

I wanted to use this opportunity to bring you up to date with some of the changes that will happen in 2017. In 2015 legislation was passed to create a new way of viewing foster care titled "Continuum of Care Reform (CCR)" which will be implemented on January 1, 2017.

#### The purpose of CCR:

- Have all children live with a committed, permanent and nurturing family with strong community connections.
- Have support for children that will be individualized and coordinated across systems, meaning children shouldn't have to change
  placement to get services.
- When children go to group homes they will be there for a very short time and then be placed back into their community.
- Child and Family Team (CFT) meetings will drive case planning, placement decisions and care coordination. All children will be involved with their CFT.
- There will be a new rate system that will not be "age based" but based on "level of care". This will affect you the most. The State of California is creating the protocol for this and I will update you as they send us the information later in the year of 2017.
- There will be a new home study which we refer to as our "psychosocial". The State is focusing on permanency so they want foster parents to be prepared to adopt (if they chose to do so). During the next three years all current and new foster parents will need to complete this new home study. This home study will now make it easier to allow parents to be ready for permanency/adoption. This does not mean you have to adopt the child placed in your home; only that you are prepared to do so if that is your choice.

One big change as of January 1, 2017, is that the name **Foster Parents** will be changed to **Resource Families**. This change was a difficult one for me to adjust to but I am now embracing it and understanding that it really reflects the changes that are coming. These changes have been huge to us and we have done some incredible things this year that will help us serve you better!

I understand that changes are not always easy to take, so my commitment to you is that we will make these changes as seamless as possible, and that as a team at Children First we will continue to support you. With the changes will be rate increases as well as some new requirements in how we care for children. Ultimately, I believe that the changes will be positive. If you would like to discuss any of these items, please give me a call.

I am proud to announce that we have become Nationally Accredited! We have become accredited through the Commission on Accreditation of Rehabilitation Facilities (CARF International), one of the top Accreditation organizations in the world. This was a requirement by the State of California and we are glad we went through this process. I

As an agency, we are preparing to be ahead of the learning curve and will provide you with information and support as we move into this new chapter of caring for children. I appreciate every one of you who has given of your time and energy for a child.

### A Word From One of Our Social Workers... Growing Together

In my time as a social worker at Children First, I've been given the opportunity to experience firsthand the joy of watching remarkable people doing incredible things:

I've seen foster parents accept, nurture and love, challenging children in the selfless hope that this gift may one day allow a child to walk their journey without being crippled by trauma and pain. I've seen children discover, sometimes for the first time ever in their life, the connections that allow them to feel whole, to feel like a member of that great social fabric we call 'family,' and to find the freedom to live, to love, and to let go of the past.



I've seen fellow social workers and staff give what they had, and then give more, because they knew that just one more meeting, phone call, or visit could make a change in a child's life. Most importantly, however, in my time at Children First, I have been given the privilege of growing together with all of you, walking with you, learning with you, growing more patient and tempered with you, and watching lives change and people flourish because of our shared belief that the fundamental goodness in all of us will emerge despite the power of hardships, pain, and fear.

I have stood alongside of you, foster parents, as you helped confused, frustrated children navigate their emotions when returning to their foster home after a visit with their biological parents, their hearts and minds unable to fully comprehend why they can't just go home with their mom and dad.

I have watched you grow and mature in this regard, and watched you find the strength and discover within yourself an ability to help and to heal no matter how difficult the situation may be. I too have grown more steadfast, more resolute, and have discovered patience within my own life as a result. It has broadened my understanding and my faith in humankind to watch your inexhaustible efforts to make it okay for a suffering child time after time, to give a child hope, for one more day, one more hour, one more moment.

I have stood alongside of you as you have let go of children, calmly hoping that they continue their journey well in another home and with another family, finding that although they may never see you again, you have given them exactly what they needed exactly when they needed it at that time in their life. This has allowed me to let go, to understand that ultimately things will be okay, to grow in the knowledge that we are in one another's lives often only for a season, but that others will carry on our work.

I have stood alongside of you, children, as you found that you can face doubts and fears with courage far beyond that of which you thought you were capable, as you walked forward despite your fears and lived your lives despite your wounds. It has been an inspiration to me, and with this I have grown to know that I too can walk forward without having all the answers, without my doubts dictating my actions, seeking the joy and connections that every human being needs and deserves.

I have stood alongside of you as you have discovered what it means to trust again, to participate, and to allow others into your lives; with this I too have grown a willingness to trust, to be a part of, to open up and allow others in my life.

I have stood alongside of you, social workers and fellow staff, and watched you willingly and persistently give 100% to the foster families and the children. I've seen you selflessly work to do things how and when they needed to be done, without fail, without compromise, and without question.

I've watched you realize that no situation, no crisis is large enough to prevent you from acting with courage, dignity, and principles. Through this I've grown to know what service truly means. I've learned that no painful experience is powerful enough to break the human spirit, and seen what dedication, professionalism, and a passion for the work and for the families really looks like

Ultimately, I am grateful to have shared these experiences with you.

I am grateful to have developed as a person and a professional alongside with you, to have been a part of your growth and your efforts, and to have developed my own as a result.

I hope to continue to stand alongside you as you discover within yourselves your purpose, and your capabilities as I continue to discover mine.

I hope, in this last analysis, that we can continue to walk this journey side by side, that we can continue to grow together.

### Recipe Corner CORNE is a new feature in Children First Quarterly. Our staff are happy to share some of their favorite old family recipes. Our first recipe comes from Jessica Berry in our Red Bluff office.

## RECIPE

وه وه وه وه وه وه وه وه وه وه

Fresh Apple Cake with Cream Cheese Walnut Frosting

a c. sugar a eggs 1 tsp. salt a c. flour 3/4 c. salad oil a tbls. Vanilla 1 tsp. baking soda 1 1/2 tsp cinnamon

1 c. chopped walnuts

4 c. chopped granny smith or golden delicious apples

Preheat oven to 350 degrees. Cream sugar and oil together, add eggs and vanilla and beat until combined. Sift together flour, sale, baking soda and Cinnamon then add to wet ingredients. Add in chopped apples and nuts. Pour batter into an ungreased 81/2" x 13 1/2" pan. Bake 45-55 minutes. Cool and frost (see below) or serve with whipped cream.

Frosting

8 oz. cream cheese 1 box powdered sugar Chopped walnuts for garnish

1 stick butter/margarine

a tsp. vanilla

Mix together cream cheese and butter. Add sugar & vanilla and beat thoroughly. Frost cake and top with chopped walnuts.
